1.SSC. Marksheet, **2.**HSC Marksheet, **3.** HSC Leaving/Transfer Certificate and Migration Certificate, **4.** NATA Score Card, **5.** Domicile of students/Parents/Birth certificate of the student.,**6.** DTE Report of verified documents.
- 2 (Two) seats are reserved for candidates, who are children of Employees of MHADA/MHAD Board. However, admission will be granted, subject to their satisfying qualifying criteria for admission. Further, Notification is awaited from the State Govt./ statutory body for the approval of this admission for the said reserved seats. If the same is not received before 10/8/2016 the seats will be allotted on merit to Institute level as per merit list based on the Inter-se Merit list.

- For all Candidates, that in the event, a candidate does not secure admission by producing the above mentioned documents for verification and then submission, and paying the fees, within the stipulated time for the specified round in which his/her name has been shortlisted, as mentioned in the Schedule, he/she forfeits the chance of admission and he/she would not be considered during the further Round(s) of filling Institutional Quota of seats.
- Post the 3 Rounds of Institutional Quota admissions, the Institute would thereafter complete the Admission process. In the event the seats are available, the same will be filled in the Vacant seat after CAP category.
- It is recommended that all the candidates should visit the college and refer the notice board for the updates.
