NOTICE - PAYMENT OF FEES FOR THE ACADEMIC YEAR 2020-21

Dear parents,

- 2. This GR has been stayed by the order of the Hon'ble Bombay High Court dated 26th June, 2020 in Writ Petition Nos. WP-ASDB-LD- VC 100/20, WP-ASDB-LD- VC 101/20, WP-ASDB-LD- VC 102/20, WP-ASDB-LD- VC 103/20. A copy of this order is available on the website of the Hon'ble Bombay High Court. The State of Maharashtra had filed SLP (Civil) Nos. 9025/2020, 9024/2020, 9065/2020, 9029/2020 and Diary No. 17837/2020 before the Hon'ble Supreme Court. By an order dated 4th September 2020, these SLPs have been disposed off with certain directions but the Hon'ble Supreme Court has not set aside or stayed or modified the order of the Hon'ble Bombay High Court dated 26th June 2020.
- 3. Despite the fact that the order of the Government of Maharashtra dated 8th May, 2020, issued under शासननिर्णयक्र.संकीर्ण २०२० /प्र. क्र.३३/एसएम-६, has been stayed, the management has decided that for this Academic Year, due to the unusual situation caused due to the continuation of the COVID-19 pandemic till date, the parents would be required to pay the fees paid by them for the Academic Year 2019-20 as fees for the current Academic Year 2020-21. The fees are tabulated below:
