Minutes of 3rd PTA EC Meeting held on 2rd April'2025-Wednesday at 11.00am in the computer Lab of the school – Room No 308.

Out of 21members, 18 members were present for the meeting.

1)The meeting commenced at 11.15 am. The Secretary of PTA EC-Mrs Supriya Padvekar welcomed all the members on behalf of the school. It was declared that out of the total number of 21 members of PTA EC, 18 members were present. Since more than 50% of PTA EC members were present, the required quorum under the Maharashtra Education Institutions (Regulation of Fee), Rules, 2016 was fulfilled.

The Chairperson of the meeting was requested to start with the meeting.

- 2) The Chairperson of PTA EC Mrs. Smita Dhuri asked the members whether they had received the Notice & Agenda dated 15/03/2025 for the meeting. All the members accepted that they had received the notice & agenda for the meeting.
- 3) The Chairperson read out the 2nd item of the agenda which was to brief about the status of Fee defaulters & inform the Parent-Members about it. The Chairperson informed the Parent-Members that a total amount of Rs 3,72,000/- is still pending which needs to be collected from the parents of different classes. The Chairperson appealed to the members to speak to the parents of their respective classes & request them to clear the fee arrears along with the notified late fees at the earliest.
- 4) The Chairperson next read out the 3rd item of the agenda which was to inform the members about the academic activities conducted by the school in the second term of the Academic Year 2024-25. She declared that regarding the same, the secretary would brief the Parent-Members.

With the help of PPT, the secretary provided complete details about academic activities conducted by the school during the second term of the academic year 2024-25.

5) Further the secretary asked the Parent-Members if they had any query regarding other matters. The Parent-Members replied that they had no other queries to be discussed.

6) Mr. Vaze – Parent-Member of Std- 6E2 suggested that students should be asked to maintain workbooks of all the subject to enhance the habit of self-study. 7) Mrs.Nandini Sharma- Parent-Member-9thE1 suggested to provide the option of opting composite subject (Hindi+Sanskrit=50 Marks each) to the students from Std-VIII to X.

The Chairperson suggested that since number of students in the class is less, it would be difficult to implement this pattern. The Chairperson further told that the school would surely think about this suggestion.

- 9) The meeting drew to a conclusion at 12.15pm with vote of thanks proposed by the secretary, PTA EC thanking all the members for their presence.
