Subject: Payment of Fees for students progressing to Std. 9 in the Academic Year 2025-26 and who have been admitted under the RTE reserved seats

- This notice is applicable only to parents whose children are studying in Std. 8
  and who were admitted under the Free Seats under the RTE Act. These
  parents have not paid any Fees for Std. 1 to Std. 8.
- 2. As you are aware, the provisions of the RTE Act are applicable only up to Std. 8.
- 3. Therefore, parents who have admitted their wards under the 25% seats reserved under the RTE Act are required to pay Fees once their children enter Std. 9.
- 4. The Fees for Std. 9 for Academic Year 2025-26 have already been displayed on the School Website (www.ies.edu/bhandupsecondary//) and on the School Notice Board vide notice Ref: IES/SEC/497/2023-24 dated 25.12.2023.
- 5. Parents are hereby given notice to carefully read the above-referred Fee notice for Std. 9, and confirm to us in writing within 15 days of this notice, as to whether they propose to continue the education of their child in our School in Std. 9 for Academic Year 2025-26 and for succeeding Academic Years, and also their readiness and willingness to pay the notified Fees for Academic Year 2025-26 and for succeeding Academic Years, within the time specified by the school for the payment of fees.
