**FURTHER RESOLVED UNANIMOUSLY** by all members present that Late fee of Rs.1/- per day be charged from the students who pay the fees after the due date.

**FURTHER RESOLVED UNANIMOUSLY** by all members present t that Exams like scholarship, Government drawing exams, NTS, VVM etc which are optional for the students and the fees /charges to be paid for such exams shall be as per the circulars received from the conducting authorities from time to time.

**FURTHER RESOLVED UNANIMOUSLY** by all members present that Administrative charges towards Duplicate Leaving Certificate, Bona fide Certificate etc will be displayed on the school notice board from time to time and will be paid by the concerned students.

**FURTHER RESOLVED UNANIMOUSLY** by all members present that as a special case and , without creating any precedence whatsoever, parents who wish to pay the Annual Fees before 30<sup>th</sup> June of that Academic Year ( which is purely voluntary for the parents) would be required to pay the fees as under :

- **FURTHER RESOLVED UNANIMOUSLY** by all members present that parents paying annual fees will have the option of either paying online or thru cheque/ demand draft.
- **FURTHER RESOLVED UNANIMOUSLY** by all members present that Fees be paid by Cheque or Demand Draft Only.
- **FURTHER RESOLVED UNANIMOUSLY** by all members present that parents not opting to pay annual fees will be given the option of paying Half yearly fees (i.e. in 2 Instalments) or Quarterly fees (i.e. in 4 Instalments) as per dates to be separately displayed on the school notice board.
- **FURTHER RESOLVED UNANIMOUSLY** by all members present that in case of charges levied by the Bank for dishonor of cheques deposited by the parents, the school is authorized to recover the cheque dishonour charges along with Administrative charges from the parents whose cheques have been dishonored.
