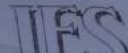

NOTICE TO ALL PARENTS

Dear Parents,

1. At the outset, while hoping that all of you are staying healthy and safe, we would like to thank all the parents who have been regular and diligent in paying their fees for all the Academic Years, including 2020-21 and have commenced payments for the Academic Year 2021-22. This has gone a long way in helping us meet our commitments & expenses.
2. As you are aware, Indian Education Society (IES) has suo-motu reverted the Fees to Fees of the Academic Year 2019-20 as fees required to be paid for the Academic Year 2020-21.
3. This decision was communicated to all parents vide notices put up on the School website / campus gate / School notice board in September 2020.
4. This was done by IES for their parents, despite the Hon'ble Bombay High Court passing an interim order, staying the Government of Maharashtra GR dated 08.05.2020, in respect of school fees.
5. By their judgment and order dated 01.03.2021, the Hon'ble Bombay High Court has disposed of the petitions related to this Maharashtra Govt. GR dated 08.05.2020.
6. In this Order which is applicable to all Schools in Maharashtra, the Hon'ble Bombay High Court has, inter alia, stated that parents can dispute only that component of Fees of the Academic Year 2020-21 which is an increase over the Fees for the Academic Year 2019-20.
7. We have been advised that since IES has suo-motu reverted to the Fees of the Academic Year 2019-20 as fees required to be paid for the Academic Year 2020-21, the exceptions set out in the aforesaid judgment and order dated 01.03.2021 are not applicable to IES schools.
8. IES has also put up regular notices on School website / campus gate / School notice board informing the parents to clear fee arrears.

9. From March' 2021, we have also informed all parents about the consequences to be faced in the event of parents not clearing fee arrears.

10. By notices sent in the last week of May 2021 sent individually to all parents who were in Fee default till that date we have once again reminded the parents to clear all the fee arrears on or before 31.05.2021, and, as a special case and, without creating any precedent whatsoever, we have also waived the late Fee charges payable for delaying payment of Fees of the Academic Year 2020-21.

11. While many parents have cooperated and cleared the dues, we still find that parents have not cleared their Fee Arrears for the Academic Year 2020-21.

12. Several parents are seeking extension of time for clearing their fee arrears, promising to clear the fee arrears and requesting that their children be granted access to the online classes.

13. IES management has accepted this request from these parents as a very special case and, without creating any precedent whatsoever the following time extension has been granted to all parents for clearing their respective fee arrears, including that of the Academic Year 2020-21.

- a. 1st instalment – 40% of Tuition Fee Arrears along with the entire Term Fee Arrears and the entire PTA Fees of the Academic Year 2020-21 (without any late fee charges) alongwith the entire fee arrears for the previous years (with applicable late fee charges) to be paid by 3 separate cheques, in the name of the respective fee accounts to be handed over to the School.
- b. 2nd instalment – 20% of Tuition Fee Arrears of the Academic Year 2020-21 to be paid on or before 10.07.2021.
- c. 3rd instalment – 20% of the Tuition Fee Arrears of the Academic Year 2020-21 to be paid before 10.08.2021.
- d. 4th instalment – 20 % of the Tuition Fee Arrears of the Academic Year 2020-21 to be paid before 10.09.2021.
- e. In addition, an Undertaking will have to be submitted to the School, in the pre printed format of the school, signed by both the parents in the presence of the School staff.

Along with this Undertaking post-dated cheques for the 2nd, 3rd and 4th instalments shall be submitted to the School office for depositing in the Bank on the due date as specified above.

The online access will be granted only to those parents who clear the Fee Arrears as per 'a' above and the amount is credited to the respective School Bank Accounts and who also submit the Undertaking alongwith Post Dated cheques for the 2nd, 3rd and 4th instalments.

Parents are advised that in the event of default in payment / non encashment of any one of the balance instalments for any reason whatsoever, the online access to Education/ physical schooling (if it has restarted) will be discontinued without any further notice, and this will be granted only after all balance Arrears are cleared by the parents, along with applicable cheque dishonour / cheque return charges.

Parents are advised that while they are clearing the fee Arrears of the previous Academic Years, they should start simultaneously paying the Fees for the Academic Year 2021 -22 as per the notices displayed on the School website / campus gate / School notice board.

We thank all those parents who have cleared their entire Fee Arrears including that of the Academic Year 2020-21 and those parents who have started paying the Fees for the Academic Year 2021-22.
