- This Resolution dated 8<sup>th</sup> May, 2020, has been stayed by the Hon'ble Bombay High Court, by their interim order dated 26<sup>th</sup> June, 2020, passed in WP-ASDB-LD-VC-100/20, WP-ASDB-LD-VC-101/20, WP-ASDB-LD-VC-102/20 and WP-ASDB-LD-VC-103/20.
- The PTA EC approved fees for the Academic Year 2020-21 and the last date for payment of fees, is as under
