1. You are aware of the order of the Government of Maharashtra dated 8<sup>th</sup> May, 2020, issued under शासननिर्णयक्र.संकीर्ण - २०२० /प्र. क्र. ३३/एसएम-६, under which directions had been given on the issue of payment of school fees.
2. This GR has been stayed by the order of the Hon'ble Bombay High Court dated 26<sup>th</sup> June, 2020 in Writ Petition Nos. WP-ASDB-LD- VC 100/20, WP-ASDB-LD- VC 101/20, WP-ASDB-LD- VC 102/20, WP-ASDB-LD- VC 103/20. A copy of this order is available on the website of the Hon'ble Bombay High Court. The State of Maharashtra had filed SLP (Civil) Nos. 9025/2020, 9024/2020, 9065/2020, 9029/2020 and Diary No 17837/2020 before the Hon'ble Supreme Court. By an order dated 4<sup>th</sup> September 2020, these SLPs have been disposed off with certain directions but the Hon'ble Supreme Court has not set aside or stayed or modified the order of the Hon'ble Bombay High Court dated 26<sup>th</sup> June 2020.
3. Parents of children who were in Mini KG, Jr. KG & Sr. KG in the Academic Year 2019-20 and who have not paid the fees, either in full, or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail, within 2 weeks from the date of this notice.

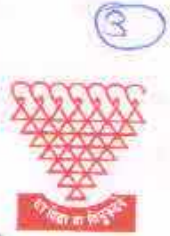

- 7. Fee arrears, alongwith applicable late fee charges are required to be paid in its entirety. If fee arrears are not completely paid, the balance of such fee arrears will invite further late fee charges.
- 8. If the fee arrears plus late fee payment charges are not cleared in its entirety, the amounts paid would be first apportioned / adjusted towards the earliest fee arrears plus late fee payment charges and balance, if any, would be adjusted towards the later fee arrears, in successive Academic Years.
- 9. Any dishonour of any of the cheques or, any instructions given by the parents resulting in non-realisation of the cheques/ reversal of transactions will result in the parents being required to pay the bank charges for each such cheque return/ reversal of transaction, alongwith administration fees of Rs. 500/- per such cheque.
- 10. Late fee charges have been calculated upto 29<sup>th</sup> February 2020. The same is not being charged for the period 1<sup>st</sup> March 2020 to 31<sup>st</sup> October, 2020. Any payment of fee arrears post 31<sup>st</sup> October 2020 will entail payment of late fee charges.
- 11. Notices are being sent by emails/ post to individual parents in fee arrears, reminding them of the outstanding fees to be paid by them.
