The following members attended the meeting of the PTAEC.

- The meeting commenced at 11.00 a.m. The Chairperson Smt. Ranjana Markad declared that out of the total number of 17 PTAEC Members, all 17 members were present and attended the meeting. - Chairperson requested parents of online students to ensure that their ward is dressed properly.
- Chairperson assured that the school is following all the protocols as per the government guidelines for offline as well as online classes.
