NOTICE OF FEE STRUCTURE FOR STUDENTS OF STDS II TO STD. IV FOR ACADEMIC YEAR 2021-22

As you are aware, despite the stay granted by the Hon'ble Bombay High Court on 26.06.2020 to the Maharashtra Government GR dated 08.05.2020, the management decided to implement the GR dated 08.05.2020 and therefore notified that the parents across all standards were required to pay the PTA EC approved and notified fees for the Academic Year 2019-20 as the fees for the Academic Year 2020-21, despite the fact that this would lead to drastically reduced fee collection and subsequent financial strain on the management.

We are one of the few managements which paid all their eligible employees their salaries on time every month and continue to do so every month.

The management has decided not to increase the tuition fees and term fees for the Academic Year 2021-22 but maintain the same fees as that approved by the PTAEC and notified for the Academic Year 2020-21, despite the fact that this would lead to further financial strain on the School and the management due to the drastically reduced Fee collection.


- If parents are depositing the cheque/s directly in the notified bank account or dropped in the drop box :
