FURTHER UNANIMOUSLY RESOLVED / by a majority of 20:21 that parents paying annual fees will have the option of either paying online or thru cheque/ demand draft.

FURTHER UNANIMOUSLY RESOLVED / by a majority of 20 21 that Fees be paid by Cheque or Demand Draft Only.

FURTHER UNANIMOUSLY RESOLVED / by a majority of 20: 21 that parents not opting to pay annual fees will be given the option of paying Half yearly fees (i.e. in 2 Instalments) or Quarterly fees (i.e. in 4 Instalments) as per dates to be separately displayed on the school notice board.
