Dear parents ,

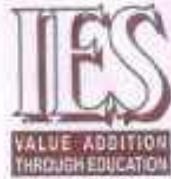

This GR has been stayed by the order of the Hon'ble Bombay High Court dated 26<sup>th</sup> June, 2020 in Writ Petition Nos. WP-ASDB-LD- VC 100/20, WP-ASDB-LD- VC 101/20, WP-ASDB-LD- VC 102/20, WP-ASDB-LD- VC 103/20. A copy of this order is available on the website of the Hon'ble Bombay High Court.

*Parents whose children were in STD. X in the Academic Year 2019-20 and have not paid the fees, either in full or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail within 1 week from the date of this notice.*

*Parents of children who were in Stds. V to IX in the Academic Year 2019-20 and who have not paid the fees, either in full, or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail, within 2 weeks from the date of this notice.*

The fee arrears, along with the late fees ( total fee arrears ) , should be paid into the respective school bank accounts, either by a crossed cheque in the name of the school, or by bank transfer into the school bank account, as under :

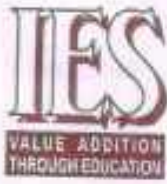

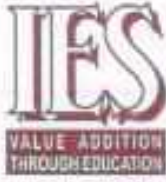
