Subject: Payment of Fees for students progressing to Std. 9 in the Academic Year 2024-25 and who have been admitted under the RTE reserved seats

1. This notice is applicable only to parents whose children are studying in Std. 8 and who were admitted under the Free Seats under the RTE Act. These parents have not paid any Fees for Std. 1 to Std. 8.
2. As you are aware, the provisions of the RTE Act are applicable only up to Std. 8.
3. Therefore, parents who have admitted their wards under the 25% seats reserved under the RTE Act are required to pay Fees once their children enter Std. 9.


