2. This Resolution dated 8th May, 2020, has been stayed by the Hon'ble Bombay High Court, by their interim order dated 26th June, 2020, passed in WP-ASDB-LD-VC-100/20, WP-ASDB-LD-VC-101/20, WP-ASDB-LD-VC-102/20 and WP-ASDB-LD-VC-103/20.

11. The fees, approved by the PTA EC under the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, is subject to the challenge before the Hon'ble Bombay High Court to the legality and validity of the Act.
