You are aware of the order of the Government of Maharashtra dated 8th May, 2020, issued under शासननिर्णयक्र.संकीर्ण - २०२० /प्र. क्र. ३३/एसएम-६, under which directions had been given on the issue of payment of school fees.

This GR has been stayed by the order of the Hon'ble Bombay High Court dated 26th June, 2020 in Writ Petition Nos. WP-ASDB-LD- VC 100/20, WP-ASDB-LD- VC 101/20, WP-ASDB-LD- VC 102/20, WP-ASDB-LD- VC 103/20. A copy of this order is available on the website of the Hon'ble Bombay High Court.

Parents of children who were in Stds. Mini KG, Jr. KG & Sr. KG in the Academic Year 2019-20 and who have not paid the fees, either in full, or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail, within 2 weeks from the date of this notice.
