WP-ASDB-LD- VC 100/20, WP-ASDB-LD- VC 101/20, WP-ASDB-LD- VC 102/20, WP-ASDB-LD- VC 103/20. A copy of this order is available on the website of the Hon'ble Bombay High Court. The State of Maharashtra had filed SLP (Civil) Nos. 9025/2020, 9024/2020, 9065/2020, 9029/2020 and Diary No. 17837/2020 before the Hon'ble Supreme Court. By an order dated 4th September 2020, these SLPs have been disposed off with certain directions but the Hon'ble Supreme Court has not set aside or stayed or modified the order of the Hon'ble Bombay High Court dated 26th June 2020.
