- Interest-Free Refundable Security Deposit has to be paid in full along with all other Fees at the time of admission. No part payment will be accepted.
- The receipt for Interest-free refundable Security Deposit will be issued by "Indian Education Society" in the name of the parents.
- Parents must collect the Receipt for this Interest-free Refundable Security Deposit" from the School / Kindergarten Administrative office within the time specified, and carefully preserve this receipt.
- When the student completes her / his education in the School by completing Std. 10, or when parents withdraw the student from the School, this Interest-Free Refundable Security Deposit will be refunded to the parents, subject to any apportionment to be made therefrom against any damage caused to school property by the student.
- This Interest-Free Refundable Security Deposit shall be refunded against an application to Indian Education Society, signed by both the parents <u>enclosing the original receipt issued by Indian Education Society</u>. This application should be <u>submitted to the office of the school and the school shall forward the same to Indian Education Society</u>.
