- You are aware of the Resolution of the Government of Maharashtra dated 8<sup>th</sup> May, 2020, in respect of payment of school fees.
- This Resolution dated 8<sup>th</sup> May, 2020, has been stayed by the Hon'ble Bombay High Court, by their interim order dated 26<sup>th</sup> June, 2020, passed in WP-ASDB-LD-VC-100/20, WP-ASDB-LD-VC-101/20, WP-ASDB-LD-VC-102/20 and WP-ASDB-LD-VC-103/20.
- The PTA EC approved fees for the Academic Year 2020-21 and the last date for payment of fees, is as under:

- 8. Any dishonour or non-encashment of any of the cheques or, any instructions given by the parents resulting in non-realisation of the cheques will result in the parents being required to pay the bank charges for such cheque returned along with administration fees of Rs. 500/- per cheque.
- 9. The dishonour of fee payment cheques paid for the entire academic year's fees would result in cancellation of the reduced fee structure tabulated in paragraph 7 above and the parents would be required to pay the fees as per the table at paragraph 3.
- 10. The fees, approved by the PTA EC under the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, is subject to the challenge before the Hon'ble Bombay High Court to the legality and validity of the Act.
- 11. In case of non IES students seeking admission in any of the standards against vacancies, if any available, they will have to await a notice for the admission process for vacancies.
