Mr. Aditya Naringrekar duly appointed videographer was also present from the commencement of the meeting for video recording the proceedings.

- The Meeting commenced at 2.00 PM. The Chairperson declared that out of the total number of 13 PTAEC Members, all 13 members were present and attending the meeting. Therefore, the quorum required under the Maharashtra Educational Institutions (Regulation of Fee) Rules, 2016, has been complied.
- 2. The Chairperson asked the members whether they had received the Notice dated 1<sup>st</sup> December, 2018, along with the Agenda for today's meeting. All the members accepted that they had received this Notice. The Chairperson then asked the

members whether they have received the proposal for approval of fees dated 01.12.2018, for the Academic Years 2019-20 and 2020-21, which had been received by him as the Chairperson of this Committee. All the members accepted that they had received the proposal for approval of fees dated 01.12.2018 for the Academic Years 2019-20 and 2020-21.

- 3. The Chairperson asked the members whether he could dispense with reading the Notice and the Agenda for the meeting since all the members had accepted receiving the Notice and the Agenda. The members accepted his request for dispensing with reading the Notice and the Agenda for the meeting.
- 4. The Chairperson proceeded to the first item on the Agenda, which was confirmation of the minutes of this Committee's meeting held on 18.08.2018. He enquired from the members whether they approved the Minutes of the Meeting which was sent by speed post to them. All the members accepted that they had received the draft minutes of the meeting held on 18.08.2018 and they approved the minutes without any modification / or corrections to the same. It was therefore, resolved as under: "RESOLVED UNANIMOUSLY THAT the minutes of the meeting held on 18.08.2018 be and is hereby approved.
- 5. The Chairperson thereafter proceeded to the second item on the Agenda, which was the proposal dated 01.12.2018 for approval of fees for the Academic Years 2019-20 and 2020-21. The members discussed the fee proposal and examined the same with regard to the provisions of The Maharashtra Educational Institutions (Regulation of Fee) Act, 2011 read with The Maharashtra Educational Institutions (Regulation of Fee) Rules, 2016.

The Chairperson explained to the members that the increase in fees was due to the increase in expenses towards salaries (Revised Pay Scales), rent, taxes, electricity charges, water supply charges, telephone charges, internet connectivity and infrastructural changes in classrooms along with transportation charges and entry fees/administration fees to be paid by the school for several competitions in which the students participated, technology based systems, Teaching aids, service providers like Security Guards, Housekeeping, Repairs & maintenance .The existing Std. I have less strength i.e only 30 per class and 5 divisions. So only 150 students pay fees. Rest is

reserved for RTE (25%). But the expenses are the same for all. So to generate revenue required for the school expenses the only source is fees.

6. When the fee proposal was placed before the members for their approval, all members unanimously accepted and approved the fee proposal, without any changes or modifications.

Thus the proposal of IES management for the fees for the Academic Years 2019-20 and 2020-21 were unanimously approved by the PTAEC 2018-19 of IES New English Primary School.
