- 2. Some parents have not paid the fees for the Academic Year 2020-21 till date and are therefore in arrears of fees.
- 3. Due to the extra ordinary situation due to the COVID-19 pandemic, the management has taken a decision not to collect late fee charges for this Academic Year. The management has not calculated any late fees for the Academic Year 2020-21, and have advised parents to pay their Fees by 31-3-2021, without any levy of Late Fees.
- 4. Parents' attention is invited to the judgment and order of the Hon'ble Bombay High Court dated 01.03.2021 in Writ Petition (Stamp) Nos. 95629 of 2020 and connected matters. This order is available on the website of the Hon'ble Bombay High Court. The Hon'ble Bombay High Court has held, inter alia, that the Government Resolution dated 8th May 2020 is only prospective in nature and cannot apply to schools which have already fixed/declared their fee for the Academic Year 2020–2021 and/or where such fees are duly accepted in terms of the 2011 Act as amended and/or has been acted upon before the resolution dated 8th May 2020. Therefore, Parents are required to pay the notified fees for the Academic Year 2020-21.


