NOTICE OF FEE STRUCTURE FOR STUDENTS ADMITTED TO STD. I IN THE ACADEMIC YEAR 2021-22

1. In exercise of the powers vested in them under S. 6 (1A) read with S. 6 (1C) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, the management declares the fee structure for students entering Std. I in the Academic Year 2021-22 (2021-22 batch), as tabulated below. This fee structure is only applicable for students entering Std. I in the Academic Year 2021-22 and till their **STD. IV** in Academic Year **2024-25**. The fee structure is being notified only till Std. IV since students progressing to Stds. V to X in the same campus are admitted to IES V.N. Sule English Medium Secondary School , which is a school receiving grant -in-aid.
2. Subject to the provisions of S. 6 (1C) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, which gives the right to the management to increase the fees declared under S. 6 (1A), this fee structure is applicable for the 2021-22 batch entering Std. I, till their **Std. IV** in Academic Year **2024-25**, as under:

3. In addition to the Tuition and Term Fees, the parents are required to pay:

Admission Fees of **Rs. 4,950/-** at the time of admission to Std. I, or if a student seeks admission to any of the other Standards as their entry into the school, an amount equivalent to one month's tuition fee for that standard would have to be paid as admission fees. This amount has to be paid at the time of securing admission.

These amounts have to be paid at the time of securing admission and payment of instalments is not available for these heads of fees. Similarly, there is no reduction in these fees if the parents decide to pay the entire year's fees in advance.

4. The Tuition Fees tabulated are for every month and the Term Fees are for every term.
5. The management has exercised the right vested in them under S.3A(1) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, and has decided that the parents are required to pay the fees on a quarterly basis.
6. The management has exercised the right available to them under the proviso to S. 3A(1) of the Maharashtra Educational Institutions (Regulation of Fee) Act,2011 and offered an option to the parents to pay the fees on an annual basis.

7. MODE OF PAYMENT

- All payments shall be made either by cheque or by NET Banking. No cash payment shall be accepted under any circumstances.

8. ANNUAL FEE PAYMENT OPTION

Parents exercising the option to pay the fees on an annual basis are required to make the entire payment before 30.06.2021.

The payment to be made is as follows:

The management has exercised the discretion vested in it under the proviso to S. 3A(1) of the Maharashtra Educational Institutions (Regulation of Fee) Act,2011 and have offered reduced fees for parents choosing to make fee payments under this option.

9. FOR QUARTERLY FEE PAYMENT OPTION

Parents are required to make quarterly payments as decided by the management exercising the right vested in them under Section 3A (1) of the Maharashtra Educational Institutions (Regulation of Fee) Act,2011. The payment to be made every quarter is as follows:

For quarterly payment option, the payment will have to be credited to the School Bank Account

- on or before 05.06.2021 for the first quarter,
- on or before 05.09.2021 for the second quarter,
- on or before 05.11.2021 for the third quarter and
- on or before 05.01.2022 for the fourth quarter.

10. **FOR PAYMENT THROUGH NET BANKING**

- In case of parents making payment through Net Banking, after payment is made, an email may be sent by the parents to the School email id pdemp.primary.english@ies.edu
- In the subject of the email, the name of the student and standard for which the Fees have been paid should be entered.
- Complete details of payment made through Net Banking such as UTR No., Bank Account through which the payment has been made should be informed to the School to enable the School to reconcile the payment received and issue appropriate receipts.

11. **FOR PAYMENT BY CHEQUE**

- Cheque/s can be deposited by the parents either directly in the notified bank accounts or can be dropped in the school box in the school premises/submitted to the school administration office.
- If parents are depositing the cheque/s directly in the notified bank account or dropped in the dropbox:
 - A. After payment is made, and email may be sent by the parents to the school email ID pdemp.primary.english@ies.edu;
 - B. The subject of the email, the name of the student in standard for which the fees have been paid should be entered and the cheque No., amount and drawer bank details should be disclosed.
 - C. This will help the school to reconcile the payment received and issue appropriate receipts.

- Parents are required to write the Name of the Student, Standard, Name of the Parent and their Mobile Number on the reverse of each cheque.
- Separate cheque is required for each Head of Fees i.e. Tuition Fee, Term Fee, PTA Fee and Admission Fee (if applicable).

12. RECEIPTS

Receipts will be emailed within 10 working days after the Fees are credited to the Schools' Bank Account. This is the default option for receipts.

Parents desiring physical receipts are requested to email the school office in advance, at the time of finishing the admission process, of their desire to collect physical receipts and to visit the school office during school working days and hours for collection of physical receipts after 10 days from the credit of the fees to the school fee account.

13. LATE FEE PAYMENT

If either the Tuition Fee and / or the Term Fee is/ are not credited to the School Bank Account on or before the notified dates set out herein, the same will be subject to late payment fee of Rs.1/- per day, for each head of default – that is, default in payment of Tuition Fee and default in payment of Term Fee will be charged separately.

14. CORRECT NOTIFIED AMOUNTS TO BE PAID

Parents are requested to ensure that correct notified amount is paid under each head of fees.

If the parents make any payment in part of the respective notified fee component, the same will not be considered as compliance of the fee payment schedule and the balance will be subject to late payment fee of Rs.1/- per day of default.
