## **RULES REGARDING INTEREST FREE REFUNDABLE SECURITY DEPOSIT**

Parents seeking admission for their child in Primary/Secondary in any IES Unaided Primary/Secondary School are required to pay an Interest Free Refundable Security Deposit as per Deposit amount specified in the Fee Notice for admissions.

- There will be no cash payment of Deposit under any circumstances.
- This amount will be paid by Crossed Account Payee Cheque, payable at Mumbai, in the name of "Indian Education Society".
- For parents opting to pay Annual Fees ONLINE, this payment may also be made thru the ONLINE payment module. There will be no cash payment under any circumstances.
- Interest-Free Refundable Security Deposit has to be paid in full along with all other Fees at the time of admission. No part payment will be accepted.
- The receipt for Interest-free refundable Security Deposit will be issued by "Indian Education Society" in the name of the parents.
- Parents must collect the Receipt for this "Interest-Free Refundable Security Deposit" from the School office during school working days and hours for collection of physical receipts, 10 days after the credit of the security deposit amount to IES account and carefully preserve this receipt.
- When the student completes her / his education in the School by completing Std.
   10, or when parents withdraw the student from the School, this Interest-Free Refundable Security Deposit will be refunded to the parents, subject to any apportionment to be made therefrom against any damage caused to school property by the student.
