NOTICE OF FEE STRUCTURE FOR STUDENTS ADMITTED TO STD. VI TO STD. X FOR THE ACADEMIC YEAR 2026-27 TO 2030-31 (BATCH 2021-22)

1. In exercise of the powers vested in them under S. 6 (1A) read with S. 6 (1C) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, the management declares the fee structure for students entering Std. VI in the Academic Year **2026-27 (Batch 2021-22)**, as tabulated below.
2. This fee structure is only applicable for students of Batch 2021-22, entering Std. VI in the Academic Year 2026-27 and till their STD. X in Academic Year 2030-31.

In Ganesh Nagar Vidyalaya, Primary Section is from Std. I to Std. VII. Secondary Section is from Std. VIII to Std. X. The fees declared vide this notice will be applicable in Primary up to Std. VII and in Secondary from Std. VIII to Std. X for Batch 2021-22.

3. Subject to the provisions of S. 6 (1C) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, which gives the right to the management to increase the fees declared under S. 6 (1A), this fee structure is applicable for the "**Batch 2021-22**" entering Std. VI in the Academic Year 2026-27, till their Std. X in Academic Year 2030-31, as under:

In case, any student takes admission in STD VI to STD X in subsequent Academic Years for this "Batch 2021-22", the fee structure specified above of that year will be applicable for such admissions.

The non-refundable one-time Admission Fee for STD. VI to X will have to be paid only by those students who are seeking admission to this school as a fresh admission / new admission.

4. INTEREST FREE REFUNDABLE SECURITY DEPOSIT

For parents seeking fresh admission / new admission for their wards, they will have to pay Refundable Interest Free Security Deposit by cheque in the name of "INDIAN EDUCATION SOCIETY".

The deposit amount for admission in Academic Year 2026-27 is Rs.10,000/-

The rules of refund of this Interest Free Refundable Security Deposit are displayed on the notice board and the School Website. Parents are required to understand the same and comply with these rules.

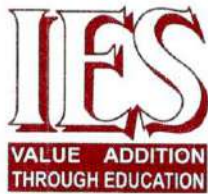
5. The management has exercised the right available to them under the proviso to S. 3A (1) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011 and offered an option to the parents to pay the fees on an annual basis.

5.1 ANNUAL FEE PAYMENT OPTION at the time of admission

Parents exercising the option to pay the fees on an annual basis are required to make the entire payment at the time of admission of that Academic Year,

5.2 For parents of existing students who wish to avail rebate, they will have to pay the Annual Fees such that the amount is credited to the School Account before 30th June of that year.

6. HALF-YEARLY AND QUARTERLY PAYMENT OPTIONS – EXISTING STUDENTS

The management has exercised the discretion vested in them under S.3A (1) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, and has decided to offer the parents the option to pay the fees on half yearly or quarterly basis.

Payment for 2nd instalment has to be by post-dated cheque, payable on or before the due date as specified above, all payable in Mumbai, to be submitted to the school along with cheque of first instalment.

7. MODE OF PAYMENT

7.1 **No cash payment shall be accepted under any circumstances.**

7.2 Online payment

Parents opting for Annual payment have the option of making online payment.

School will provide a link to the parents' email ID to make online payment.

7.3 Payment by cheque

Parents opting for payment by cheque should deposit the cheques separately for each Head of payment such as Tuition Fees, PTA Fees, Admission Fees (when applicable).

A separate detailed notice about the rules regarding the mode of payment, Late Fees, cheque dishonour etc. is displayed on the Notice Board / Website. Parents should make themselves familiar with these rules and comply with the same.

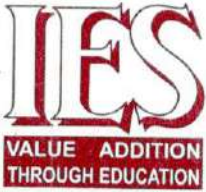
7.4 PAYMENT BY CHEQUE

- Cheque/s can be deposited by the parents either directly in the notified bank accounts or can be dropped in the school drop box in the school premises or submitted to the school administration office.
- If parents are depositing the cheque/s directly in the notified bank account or are putting in the drop box in the school; following steps are to be followed.
 - A. After payment is made, and email may be sent by the parents to the school email ID: gnv.titwala.primary@ies.edu / gnv.titwala.secondary.english@ies.edu
This email should be sent within two days of payment.
 - B. In the subject of the email, the name of the student and the standard for which the fees have been paid should be entered.
 - C. In the email, following details should be specified.

D. This will help the school to reconcile the payment received and issue appropriate receipts.

- Parents are required to write the Name of the Student, Standard, Division, Name of the Parent and their Mobile Number on the reverse of each cheque.
- Separate cheque is required for each Head of Fees i.e. Tuition Fees, PTA Fee and Admission Fee (if applicable).
- For parents choosing Half yearly or Quarterly payment options, the post-dated cheques for the subsequent instalments must be submitted to the school office along with the payment of 1st instalment.

8. LATE PAYMENT FEE

If the Tuition Fee is not credited to the School Bank Account on or before the notified dates set out herein, the same will be subject to late payment fee of Re. 1/- per day as per rules.

9. CORRECT NOTIFIED AMOUNTS TO BE PAID

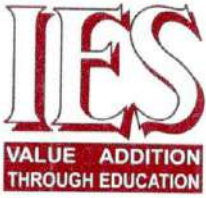
Parents are requested to ensure that correct notified amount is paid under each head of fees. If the parents make any payment in part of the respective notified fee component, the same will not be considered as compliance of the fee payment schedule and the balance will be subject to late payment fee of Re. 1/- per day of default as per rules.

10. DISHONOUR OF CHEQUES/ STOP PAYMENT INSTRUCTIONS

Any dishonour / stop payment instruction of cheques issued by the parents towards any of the heads of fees or for interest free refundable security deposit will be treated as non-payment of fees and will be subject to late payment fee as calculated above, In addition, bank charges levied on the school for such cheque dishonour along with administrative charges shall be recovered from the parents.

The additional amount towards bank charges & administrative charges shall be Rs. 500/- for each cheque default, and this may be increased solely at the discretion of the Management.

If any charges are levied by the Bank/Service provider on the school for payment of Fees through credit card / debit card / Google Pay / UPI Pay / Paytm etc. the same will be required to be paid by the parent to the school.

11. ADMISSION PROCESS SHALL BE TREATED AS COMPLETED ONLY AFTER

(a) All documents along with signed application forms are submitted to the school office.

(b) Entire payment of all fees and deposits are made as notified.

If parents do not complete these procedures within the stipulated time, the admission to their ward will stand cancelled, and the decision of the Management shall be final.

If Parents/Guardians complete the admission process of your child in the School on his / her being selected for admission, Parents/Guardians are deemed to have accepted all the rules and regulations of the School, including the rules relating to payment of fees, Interest Free Refundable Security Deposit and also the fee structure announced by the School.
