Parents whose children were in STD. X in the Academic Year 2019-20 and have not paid the fees, either in full or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail within 1 week from the date of this notice.

Parents of children who were in Stds. VIII to IX in the Academic Year 2019-20 and who have not paid the fees, either in full, or in part, for the Academic Year 2019-20 and Academic Years prior to 2019-20 are requested to make payment of the arrears, with late fee charges, without fail, within 2 weeks from the date of this notice.

The fee arrears, along with the late fees (total fee arrears), should be paid into the respective school bank accounts, either by a crossed cheque in the name of the school, or by bank transfer into the school bank account, as under :
