### NOTICE OF FEE STRUCTURE FOR STUDENTS ADMITTED TO STD. I IN THE ACADEMIC YEAR 2023-24 (BATCH 2023-24)

1. In exercise of the powers vested in them under S. 6 (1A) read with S. 6 (1C) of the Maharashtra Educational Institutions (Regulation of Fee) Act, 2011, the management declares the fee structure for students entering Std. I in the Academic Year 2023-24 (**Batch 2023-24**), as tabulated below.
2. This fee structure is only applicable for students entering Std. I in the Academic Year 2023-24 and till their STD. V in Academic Year 2027-28.
3.
